This Plan of Merger dated October 30, 2009, is made and entered into between RT Business Park, LLC, a Florida limited liability company, herein referred to as the "Surviving LLC", and R. T. Business Park, L.L.C., a Georgia limited liability company, herein referred to as the "Merged LLC".

RECITALS:

- A. RT Business Park, LLC is a limited liability company organized and existing under the laws of the State of Florida, with its principal office at 205 Windsong Court, Niceville, Florida 32578.
- В. The membership of RT Business Park, LLC is held as follows:

E. The managers and members of the constituent limited liability companies deem it desirable and in the best business interests of the respective limited liability companies that R. T. Business Park, L.L.C. be merged into RT Business Park, LLC, pursuant to the provisions of Sections 608.438, et seq., of the Florida Limited Liability Company Act and Code Section 14-11-901, et seq. of the Georgia Limited Liability Company Act, in order that the transaction qualify as a

"reorganization" within the meaning of Section 368(a)(1)(A) of the Internal Revenue Code of 1986, as amended.

In consideration of the mutual covenants, and subject to the terms and conditions set forth below, the constituent limited liability companies agree as follows:

- 1. Merger. R. T. Business Park, L.L.C. (the "Merged LLC") shall merge with and into RT Business Park, LLC, which shall be the Surviving LLC. The merger shall become effective (the "Effective Date") immediately on the date on which a Certificate of Merger, together with any other documents required to be filed to consummate the merger, is filed with and accepted by the Secretary of State of the State of Florida.
- 2. <u>Terms and Conditions</u>. On the effective date of the merger, the separate existence of the Merged LLC shall cease, and the Surviving LLC shall succeed to all the rights, privileges, immunities, and franchises, and all the property, real, personal, and mixed, of the Merged LLC, without the necessity for any separate transfer. The Surviving LLC shall then be responsible and liable for all liabilities and obligations of the Merged LLC, and neither the right of creditors nor any liens on the property of the Merged LLC shall be impaired by the merger.
- 3. <u>Membership Interests</u>. As of the Effective Date, all of the outstanding membership interests in the Merged LLC, and any certificates evidencing the same, shall be canceled, and the membership interests in the Surviving LLC outstanding immediately prior to the merger shall remain issued and outstanding from and after the Effective Date.
- 4. <u>Limited Liability Company Operating Agreement</u>. The Limited Liability Company Operating Agreement of RT Business Park, LLC, as in effect on the Effective Date (the "Surviving LLC Operating Agreement") shall be the Limited Liability Company Operating Agreement of the Surviving LLC until thereafter changed or amended as provided therein or by applicable law.
- 5. <u>Management</u>. The manager(s) of the Surviving LLC on the Effective Date of the merger shall continue as the manager(s) of the Surviving LLC until such time as said manager(s) shall resign or be replaced in accordance with the terms and provisions of the Surviving LLC Operating Agreement.
- 6. <u>Approval by Members</u>. This Plan of Merger has been approved by 100% of membership interests of the constituent limited liability companies, as evidenced by their execution hereof.
