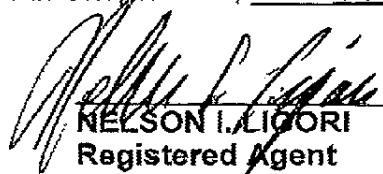

ARTICLE V- BUSINESS PURPOSE

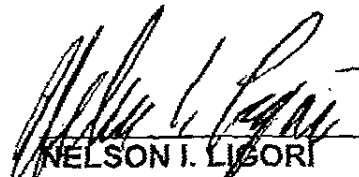
The primary business purpose of this Company is investing in securities and other financial assets, in addition to any other purposes permitted under Florida law.
