6. The conversion was effective under the laws of Delaware on September 27, 2018.

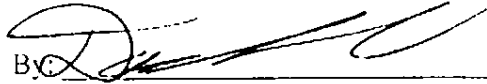
7. The conversion shall be effective in Florida on September 27, 2018.
