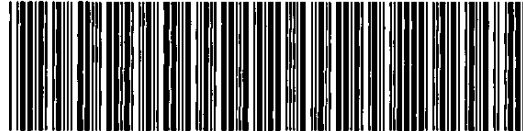

**ARTICLES OF ORGANIZATION**

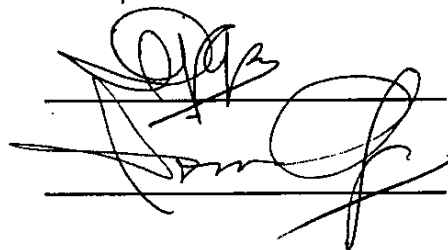
**ARTICLE V : MANAGEMENT OF COMPANY**
