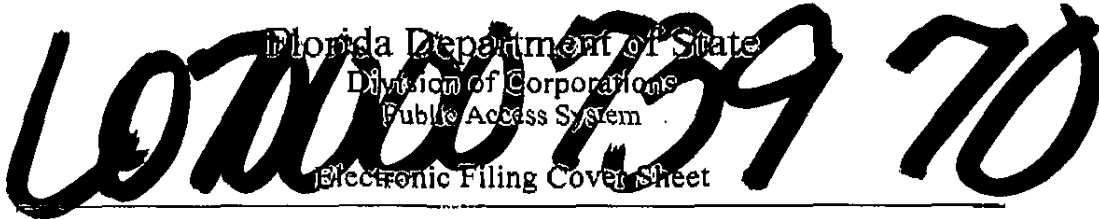


**WRITTEN CONSENT IN LIEU OF MEETING
