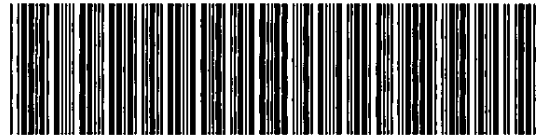

**ARTICLES OF ORGANIZATION OF
FLOWING WATERS INVESTMENTS, LLC**

Article I

The name of the limited liability company ("Company") is FLOWING WATERS INVESTMENTS, LLC.

Article II


Article VII
