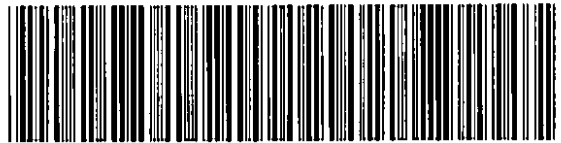

The name of the Florida Limited Liability Company is **Biosphere Consulting, LLC.**


**Article II**
