The undersigned, desiring to form a limited liability company under the provisions of Chapter 608 of the Florida Statutes, and all Acts amendatory thereto, hereby adopt(s) the following Articles of Organization:

**ARTICLE I - NAME**

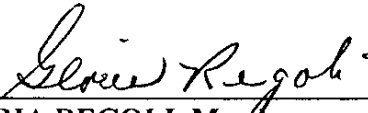

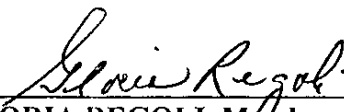
