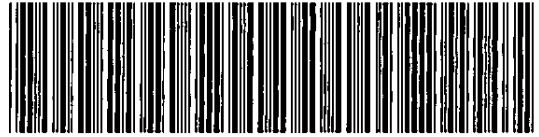

This DISSOLUTION of PARTNERSHIP AGREEMENT is made on AUG - 21, 2008

This Dissolution of Partnership Agreement for High End Contractors, LLC sets forth the terms upon which the parties named below are ending their Partnership

Parties: The parties to this agreement are:

Joselier Cerutti ("Cerutti"), CN Marble & Granite, Inc located at 2219 West 80 Street, Suite 7, Hialeah, Florida 33016 and Jorge Caceres of Caceres Drywall Corp. located at 3440 NE 192 Street Apartment #5f, Aventura, FL 33180.

As set forth in the original Partnership Agreement, the understandings contained stated that each partner had equal responsibility and equal ownership of the High End Contractors, LLC.

At this time, the Partners wish to dissolve their partnership.

Under #10 of the Partnership Agreement:

"Should any of the original partners wish to withdraw from said partnership, the, remaining partners shall have the first opportunity to equally share in the purchase of the withdrawing partner's portion."

* At this time, Jorge Caceres wishes to relinquish his control of the LLC entirely to Joselier Cerutti as and for the consideration of ten (\$10) dollars.

Any controversy or claim arising out of or relating to this Agreement, or the breach hereof, shall be taken before a mediator prior to any court action being established. Said mediation shall be considered the court ordered mediation in case the issue is filed with the appropriate court.

Should the issues not settle at mediation all disputes shall be filed in Broward County, Florida and this Agreement shall be governed in accordance with the laws of the State of Florida. The prevailing party shall be awarded reasonable attorney's fees and costs.





