AMENDED AND RESTATED
ARTICLES OF ORGANIZATION
OF
COASTAL DOG MAGAZINE, LLC

The undersigned member of COASTAL DOG MAGAZINE, LLC, a Florida limited liability company (the "Company"), whose Articles of Organization were originally filed with the Florida Department of State on July 19, 2007, adopts the following Amended and Restated Articles of Organization of the Company pursuant to the Florida Limited Liability Company Act, Chapter 608, Florida Statutes:

ARTICLE I -- NAME

The name of the limited liability company shall be COASTAL DOG MAGAZINE, LLC.

ARTICLE II -- ADDRESS

The mailing address of the Company shall be 14551 Indigo Lakes Circle, Naples, Florida 34119. The street address of the principal office of the Company shall be 14551 Indigo Lakes Circle, Naples, Florida 34119.

ARTICLE III -- DURATION

The Company's existence shall be perpetual unless the Company is earlier dissolved as provided in these Articles of Organization or in the Company's Operating Agreement.
