

ARTICLES OF ORGANIZATION OF SHADY GROVE FARMS, L.L.C. AND DESIGNATION OF REGISTERED AGENT

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Florida Statutes Chapter 608, hereby makes, acknowledges, and files the following Articles of Organization.

ARTICLE I -- NAME

The name of the limited liability company shall be: SHADY GROVE FARMS, L.L.C. (the "Company").

ARTICLE II -- ADDRESS

The street address of the principal office of the company shall be: 2879 Madison Street, Marianna, Florida 32446, with the privilege of having its offices and branches at other places within or without the State of Florida. ARTICLE III -- DURATION

ARTICLE VIII -- MANAGEMENT

The company shall be managed by the members in accordance with regulations adopted by the members for the management of the business and affairs of the company. These regulations may contain any provisions for the regulation and management of the affairs of the company not inconsistent with law or these articles of organization.






