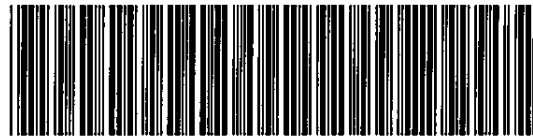



**ARTICLES OF ORGANIZATION
OF

**ARTICLE I
NAME**

The name of this Limited Liability Company (this "Company") shall be **PURESOUND, LLC**, and its principal place of business is 1942 Beacon Street, Deltona, Florida 32738 and the mailing address shall be 1942 Beacon Street, Deltona, Florida 32738.

**ARTICLE II
COMMENCE OF CORPORATE EXISTENCE**

This Company shall exist commencing upon the date of filing of these Articles of Organization with the State of Florida, Secretary of State.

**ARTICLE III
GENERAL PURPOSE; GENERAL POWERS**

The general purpose of this Company shall be the transaction of any and all lawful business. This Company shall have all of the powers enumerated in the Florida Limited Liability Company Act, as the same now exists and as hereafter amended, and all such other powers as are permitted by applicable law.

**ARTICLE IV
CONTRIBUTIONS TO CAPITAL**

The initial capital of the Company shall be Two Thousand and no/100 Dollars (\$2,000.00), which shall be contributed by the members (the "Members") in accordance with their ownership interests in the Company, which are as follows:

| JEFF HESTER | 49% |

No Member shall be entitled to receive interest on his or her contribution to capital. Each Member's contribution to capital shall be in cash or property as agreed upon by the Members. Additional contributions to capital by the Members may be required pursuant to acts of the Board of Managers.

**ARTICLE V
INITIAL REGISTERED OFFICE AND AGENT**

The initial registered office of this Company shall be located at 1942 Beacon Street, Deltona, Florida 32738, and the registered agent of this Company, at that address, shall be MIKE D. CERCOLA. The Company may change its registered agent or the location of its registered office, or both, from time to time, without amendment of these Articles of Organization.

ARTICLE VI
MANAGEMENT/INITIAL BOARD OF MANAGERS

The management of conduct of the business affairs of the Company shall be vested in a Board of Managers as provided in the Operating Agreement of the Company. This Company shall have two (2) Managers initially. The number of Managers may be either increased or decreased, from time to time, by the Operating Agreement of the Company. The name and street address of the initial Managers of this Company, who shall serve as Managers until the first annual meeting of the Members, or until his/her successor is elected and shall qualify, is:

ARTICLE VII
REGULATIONS

The power to adopt, alter, amend, or repeal the Operating Agreement of the Company shall be on such terms and conditions as determined by all Members (unanimous).

ARTICLE VIII
ADMISSION OF NEW MEMBERS

Additional Members may be admitted, from time to time, on such terms and conditions as determined by all Members (unanimous).

ARTICLE IX
DEATH, RETIREMENT, RESIGNATION, BANKRUPTCY,
EXPULSION, OR DISSOLUTION
OF MEMBER

In the event of the death, retirement, resignation, bankruptcy, expulsion, or dissolution of a Member, or the occurrence of any other event which terminates the continued membership of a Member in the Company, the remaining Members shall continue the business of the Company pursuant to the applicable provisions of law, these Articles of Organization and the Operating Agreement.

ARTICLE X
AMENDMENT

The Company reserves the right to amend or repeal any provisions contained in these Articles of Organization, or any amendments thereto, and any right conferred upon the Members is subject to this reservation.

ARTICLE XI
HEADINGS AND CAPTIONS

The headings or captions of the various Articles of Organization are inserted for convenience, and none of them shall have any force or effect, and the interpretation of the various Articles shall not be influenced by any of said headings or captions.


