## ARTICLES OF ORGANIZATION

OF

LOUSAT, LLC

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Florida Statutes, Chapter 608, hereby makes, acknowledges and files the following Articles of Organization.

### ARTICLE I

NAME

The name of the limited liability company shall be LouSat, LLC (the "Company"). The mailing and street address of the principal office of the Company in Florida shall be One Independent Drive, Suite 1900, Jacksonville, Florida 32202.

### ARTICLE II

PURPOSES AND POWERS

ADMISSION OF MEMBERS

TERMINATION OF EXISTENCE

The Company shall not be dissolved upon the occurrence of any event that terminates the continued membership of a member in the Company, provided there is at least one remaining

## ARTICLE VI

### MANAGER



The managers shall hold the offices and have the responsibilities accorded to them by the members as set forth in the Operating Agreement.

### DURATION

The Company shall exist perpetually. Corporate existence shall commence on the date these Articles of Organization are executed, except that if they are not filed by the Department of State of the State of Florida within five (5) business days thereafter, corporate existence shall commence upon filing by the Department of State.
