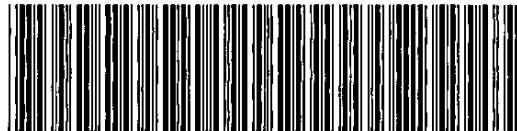

Name

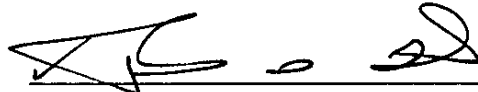

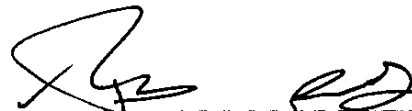
