ARTICLES OF ORGANIZATION OF Do It USA, Limited Liability Company

THE UNDERSIGNED HEREBY CERTIFY that the members described in Article V have associated themselves for the purpose of becoming a limited liability company under the laws of the State of Florida, providing for the formation, rights, privileges, and immunities of limited liability companies for profit.
