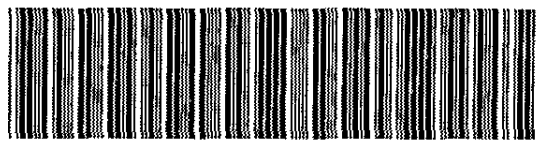

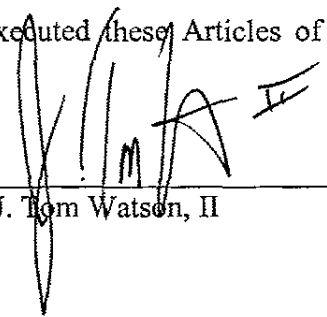
ARTICLE VI

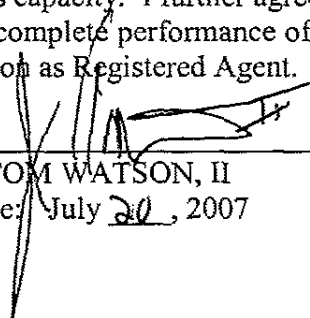
