ARTICLES OF ORGANIZATION
OF

The undersigned, desiring to form a limited liability company under and pursuant to Section 608 of the Florida Statutes, entitled the Florida Limited Liability Company Act, does hereby adopt the following Articles of Organization for such company.

ARTICLE I
NAME

The name of the limited liability company, hereinafter referred to in these Articles as "Company," is MCLM PARADISE, LLC.

ARTICLE II
ADDRESS

The Company's street address of its principal place of business in Florida is 13575 Sandy Key Drive, #317, Pensacola, Florida 32507, and its mailing address is 1650 Edgumbe Road, St. Paul, MN 55116, and it shall have the power and authority to establish branch offices at such place or places as may be designated by the Member or Members.

ARTICLE III
RESTRICTIONS ON MEMBERSHIP

Any amendment to these Articles of Organization shall be on such form prescribed by the Florida Secretary of State, containing such terms and provisions consistent with Section 608 of the Florida Statutes, as shall be prescribed by the
