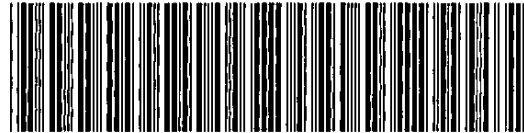

NAME

The name of the Limited Liability Company is:

ARTICLE II

TERM OF EXISTENCE

The power to adopt, alter, amend or repeal Regulations shall be vested in the members of this Limited Liability Company. Said amendment must be by a majority vote of the members.



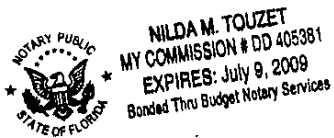


