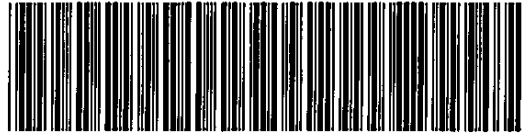



**ARTICLES OF ORGANIZATION OF  
YANTA, LLC**

**Article I**

The name of the limited liability company ("Company") is YANTA, LLC.

**Article II**

The street address of the Company's principal office is 102 N. Volusia Avenue, Pierson, Florida 32180 and the mailing address of the Company's principal office is 102 N.
