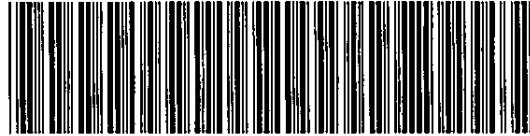

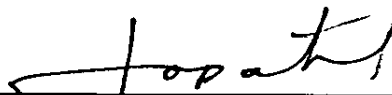

**AGREEMENT CONCERNING WITHDRAWAL OF MEMBER

WHEREAS:

- A. Withdrawing Member and Other Member are all of the current Members' of the Company.
- B. Withdrawing Member owns 10 Class B Units in Company, representing Ten percent (10.00%) of all Percentage Interest in Company.
- D. Withdrawing Member has elected to withdraw as a Member.

1.1.3. Relinquish, release, sell, assign and transfer to Company: (a) all of its Interests in Company; (b) all balances, if any, in its Capital Accounts; and (c) all rights to receive any distributions from Company.

1.2. By virtue of the foregoing, Company has redeemed the Withdrawing Member's Interests.

3. **Consent by Other Member.** Other Member hereby consents to the matters set forth in this Agreement including, without limitation, the matters set forth in paragraph 1. To the extent that it may be required.

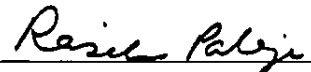
