**ARTICLES OF ORGANIZATION
OF

ARTICLE I – NAME

ARTICLE IV – REGISTERED OFFICE AND AGENT


The name and street address of the registered agent of the Company in the State of Florida is William R. Penuel, 13361 Atlantic Boulevard, Jacksonville, FL 32225.


