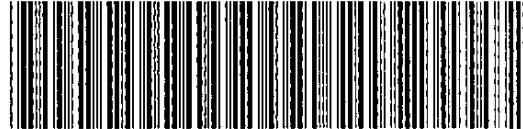

The period of duration for Flaharty & Associates, LLC shall be perpetual.


ARTICLE IV - Registered Agent:
