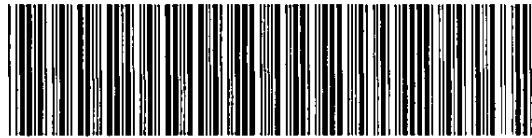

1. The name of this limited liability company is Brickell Capital Management LLC (the "Company").

2. The Company may engage in any activity or business permitted under the laws of the State of Florida. The Company shall have all of the corporate powers enumerated in the Florida Limited Liability Company Act, as amended from time to time.

3. The initial mailing address and principal place of business of this Company is 1893 S.W. 3 Street, Pompano Beach, Florida 33069.


6. The Company shall be managed by one or more managers appointed by its members. The name and address of the initial manager who shall continue to serve until replaced by the members are set forth below as follows:

The foregoing right of indemnification shall not be exclusive of any other rights to which any officer, employee or agent may be entitled as a matter of law or which he or she may be lawfully granted.


