ARTICLE I - NAME

ARTICLE V - REGISTERED OFFICE AND AGENT

The name and street address of the registered agent of the company in the state of Florida is Kofi Agyen, 2129 New Victor Road, Ocoee, FL 34761.

ARTICLE VI - ADMISSION OF NEW MEMBERS
