

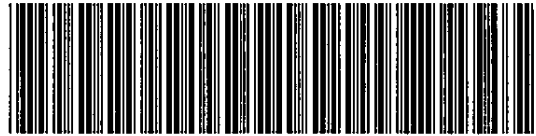

ARTICLES OF ORGANIZATION
OF
BARRACO OIL ENTERPRISES, LLC

The undersigned, for the purpose of forming a Limited Liability Company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby make, acknowledge, and file the following Articles of Organization.

ARTICLE I
NAME AND PRINCIPAL OFFICE

The name of the Limited Liability Company shall be BARRACO OIL ENTERPRISES, LLC ("Company"). The mailing address and principal office of the Company is: 8380 Aqua Cove Lane, Fort Myers, Florida 33903.

ARTICLE II
DURATION

The Company shall commence its existence upon the filing of these Articles of Organization, and its existence shall be perpetual unless the Company is dissolved as provided in these Articles of Organization.

ARTICLE III
PURPOSES AND POWERS


