ARTICLES OF ORGANIZATION OF WP LONG, LLC

The undersigned, being over the age of eighteen (18) years and competent to contract, for the purpose of organizing a limited liability company pursuant to the Florida Limited Liability Company Act, Chapter 608, Florida Statutes, does hereby adopt the following Articles of Organization, and does agree and certify as follows:

ARTICLE I

Name.

The name of the limited liability company ("Company") is WP Long, LLC.

ARTICLE II

Address

The mailing address of the Company's principal office is Post Office Box 1549, Orlando, Florida 32802 and its street address is 390 North Orange Avenue, Suite 2200, Orlando, Florida 32801.

ARTICLE III

Duration

The Company shall have a perpetual existence unless the Company ceases to have any members. If, however, within the ninety (90) days following the occurrence that terminated the membership of the last remaining member, the personal or other legal representative of that member agrees in writing to continue the Company and agrees to the admission of it or its nominee as a member, effective as of the occurrence of the event that terminated the continued membership of the last remaining member, then the Company shall not cease to exist. The Company may be dissolved upon the written consent of all of its members.

ARTICLE IV

Registered Agent and Office

The Company's initial registered agent in Florida is Donald E. Christopher. The address of Company's registered office in Florida is 390 North Orange Avenue, Suite 2200, Orlando, Florida 32801.

ARTICLE V

Management and Limitation on Authority of Members

The Company is to be managed by its members, who may select one of the members to be Managing Member. Pursuant to section 608.4235 of the Florida Limited Liability Company Act, no member of the Company, not then serving as Managing Member, shall be an agent of the Company

ARTICLE VI

Admission of New Members



Additional members may be admitted only on the consent of a majority in interest of the existing members, and the existing members shall determine the amount, value, and nature of contributions by new members at the time the new members are admitted.

ARTICLE VII

Additional Provisions

The power to adopt, alter, amend, or repeal an Operating Agreement for the Company is vested in the members.
