TAL CASH, LLC

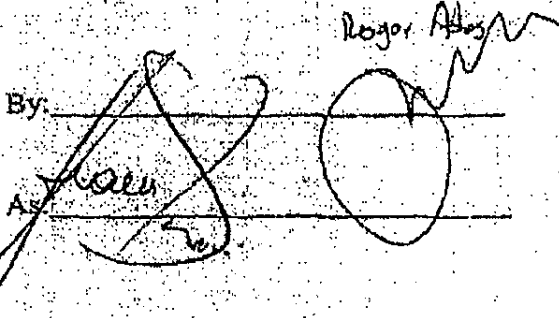

4. The revocation of dissolution was authorized in the same manner as the dissolution on September 18, 2009.

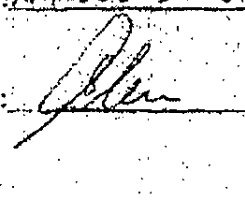
