The undersigned, for the purpose of forming a limited liability company under the Florida RIDA. Limited Liability Company Act, F.S. Chapter 608, hereby make, acknowledge, and file the following Articles of Organization.

ARTICLE I - NAME

The name of the limited liability company shall be BUILDTELLIGENCE WEB SOLUTIONS, LLC, ("company").

ARTICLE II - ADDRESS

The mailing address and street address of the principal office of the company is 18130 U.S. Highway 441, Mount Dora, FL 32757.
