Amended and Restated Operating Agreement of Business Valuation Analysts, LLC.

This first amendment to the Operating Agreement of Business Valuation Analysts (the "Amendment") made effective the 25th day of September 2024, by and among the undersigned:

Whereas, Business Valuation Analysts, LLC ("BVA") was formed with Timothy K. Bronza ("Bronza") as its sole member, August 3, 2007, document number L07000079837; and

Whereas, Mercer Capital Management, Inc. (Mercer) is purchasing 100% of Timothy Bronza's interest in BVA, and Timothy Bronza is selling 100% of his interest pursuant to the Membership Interest Transfer Agreement ("Transfer Agreement") dated September 25, 2024, attached herein and incorporated by reference; and

Whereas, pursuant to paragraph 1.1 of the Transfer Agreement, Bronza and Mercer intend that Bronza is dissociated from BVA upon execution of the Transfer Agreement; and

Whereas, Paragraph 8.3 of the Operating Agreement states that in the event of any transfer of all or any part of Bronza's interest the transferee shall not have the right to become a substituted member of, or otherwise be admitted to, BVA without the written approval of Bronza; and

Whereas, Bronza's execution of the Transfer Agreement and signature below shall serve as the written approval required of paragraph 8.3 of the Operating Agreement; and

Now, therefore, the Operating Agreement of Business Valuation Analysts, LLC, is hereby amended to reflect the sale of 100% of Bronza's membership interest in BVA to Mercer; indicating Mercer is hereafter the sole member of Business Valuation Analysts, LLC;
