**Article I  
Name**

## **Article V**

### **Purposes**

**Section 5.1 Purposes.** This professional limited liability company is organized for the sole and specific purpose of engaging in every phase and aspect of the business of rendering the same professional services to the public that an attorney, duly licensed under the laws of the State of Florida, is authorized to render, but such professional services shall be rendered only through officers, employees and agents who are duly licensed or otherwise legally authorized under the laws of the State of Florida to practice as an attorney. This limited liability company shall have all the powers conferred upon it by the laws of the State of Florida and not prohibited by the Florida Professional Service Corporation and Limited Liability Company Act; provided, however, that this limited liability company shall not engage in any business other than the rendering of the professional services described above for which it is organized. It is expressly provided that the foregoing enumeration of specific purpose shall not be held to limit or restrict in any manner the purposes in which this limited liability company is otherwise permitted by law to engage.

## **Article VI**

### **Management**

**Section 6.1 Management.** The limited liability company is to be managed by the members in accordance with the Operating Agreement of the limited liability company.

## **Article VII**

### **Operating Agreement**

**Section 7.1 Operating Agreement.** The initial Operating Agreement of this limited liability company shall be adopted by the members. The Operating Agreement shall be adopted, altered, amended or repealed from time to time as provided in the Operating Agreement.

## **Article VIII**

### **Amendment**

**Section 8.1 Amendment.** The members, by vote of members holding a majority of the interests in the limited liability company, shall have the right to amend or repeal any provision contained in these Articles of Organization; provided, however, that it shall require a vote of members holding sixty percent (60%) or more of the interests in the limited liability company to amend or repeal Article VII regarding merger.
