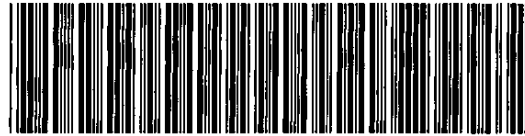

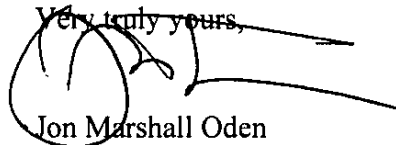

**ARTICLES OF ORGANIZATION

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Florida Statute Chapter 608, hereby makes, acknowledges, and files the following Articles of Organization.

ARTICLE I -- NAME

The name of the limited liability company shall be **ODEN FAMILY FUND, LLC** ("Company").

ARTICLE II -- ADDRESS

The mailing address and street address of the principal office of the company shall be 5341 Brookline Dr., Orlando, FL 32819.

ARTICLE III -- DURATION

The company shall commence its existence on the date these articles of organization are filed with the Florida Department of State. Its existence shall be perpetual.

ARTICLE IV -- REGISTERED OFFICE AND AGENT

The name and street address of the registered agent of the company in the State of Florida is Jon Marshall Oden, Esq., 20 North Orange Avenue, Suite 1500, Orlando, Florida 32802.

ARTICLE V -- CAPITAL CONTRIBUTIONS

The members of the company shall contribute as capital to the company cash and labor services.

ARTICLE VI -- ADDITIONAL CAPITAL CONTRIBUTIONS

Each member shall make additional capital contributions to the company only on the unanimous consent of all the member-managers.

ARTICLE VII -- ADMISSION OF NEW MEMBERS

No additional members shall be admitted to the company except with the unanimous written consent of all of the member-managers of the company and on such terms and conditions as shall be determined by all of the member-managers. A member may transfer his or her interest in the company as set forth in the Operating Agreement of the company. The transferee shall have no right to participate in the management of the business and affairs of the company or become a member or manager unless all of the other member-managers of the company, other than the member proposing to dispose of his or her interest, approves of the proposed transfer by unanimous written consent.

ARTICLE VIII -- TERMINATION OF EXISTENCE

The company shall be dissolved upon the death, bankruptcy, or dissolution of a member-manager unless the business of the company is continued by the consent of all the remaining member-managers, provided there are at least one remaining member-manager. Otherwise, the company shall be dissolved as specified in the Operating Agreement of the company.

ARTICLE IX -- MANAGEMENT

The company shall be managed by the members in accordance with Operating Agreement adopted by the members for the management of the business and affairs of the company. These regulations may contain any provisions for the regulation and management of the affairs of the company not inconsistent with law or these articles of organization. 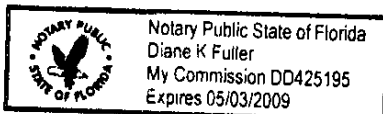

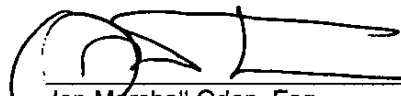
