**AMENDED AND RESTATED ARTICLES OF ORGANIZATION
FOR
FLORIDA LIMITED LIABILITY COMPANY**

The undersigned, for the purpose of amending and restating the articles of organization of a limited liability company under the Florida Revised Limited Liability Company Act, Chapter 605, Florida Statutes, hereby makes, acknowledges and files the following amended and restated articles of organization.

ARTICLE I - NAME

The name of the Limited Liability Company is MORRIS LAW OFFICES, LLC (the "Company").

ARTICLE IX - EFFECTIVE DATE

Pursuant to Section 605.0207, Florida Statutes, these Amended and Restated Articles of Organization shall be effective as of the date of filing with the Department of State.

ARTICLE X – LIMITED LIABILITY OF MEMBERS

A debt, obligation, or other liability of the Company is solely the debt, obligation, or other liability of the Company. A member is not personally liable, directly or indirectly, by way of contribution or otherwise, for a debt, obligation, or other liability of the Company solely by reason of being or acting as a member.

ARTICLE XI – INDEMNIFICATION

The Company indemnifies and holds harmless its members for and against any and all claims, demands, debts and obligations against the member by reason of the member's former or present capacity as a member to the extent permitted in Section 605.0408, Florida Statutes.

I, WENDY MORRIS, am the member or authorized representative submitting these Amended and Restated Articles of Organization and affirm that the facts stated herein are true. I am aware that false information submitted in a document to the Department of State constitutes a third degree felony as provided for in Section 817.155, Florida Statutes. I understand the requirement to file an annual report between January 1st and May 1st in the calendar year following formation of the Limited Liability Company and every year thereafter to maintain "active" status.
