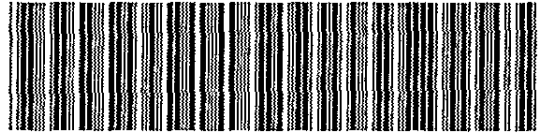

(Document Number: W07000036552 and Tracking Number: 200106869112)

After some research, I found that, according to the Florida Statute 608.406(2), "... a limited liability company may register under a name that is not otherwise distinguishable on the records of the Division of Corporations with written consent of the owner entity provided the consent is filed with the Division of Corporations at the time of registration of such name."
