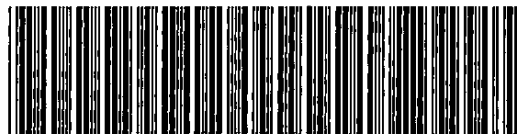

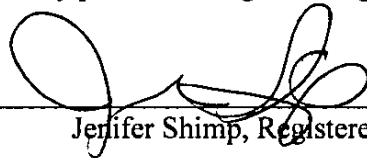

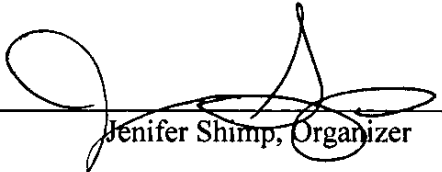
**ARTICLE IV – Duration**
