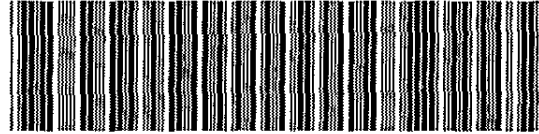

**ARTICLES OF ORGANIZATION

**ARTICLE I:** The name of this limited liability company ("the company") is CREATIVE DOCUMENTS, LLC.


**ARTICLE II:** The initial principal office and mailing address of the company is 12620-3 Beach Boulevard, #346, Jacksonville, Florida 32246.


