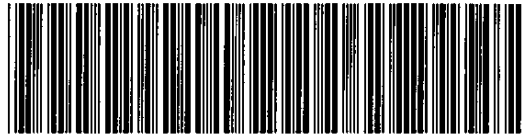

ARTICLE VI

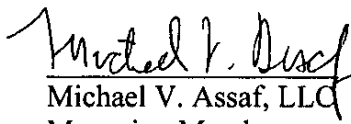

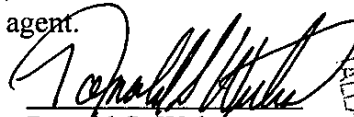
