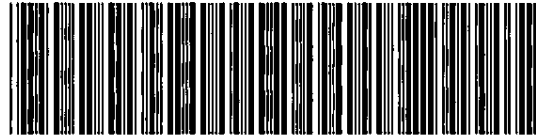


ARTICLES OF AMENDMENT

ARTICLE I: NAME The name of the limited liability company shall be A. M. FISHING, LLC.



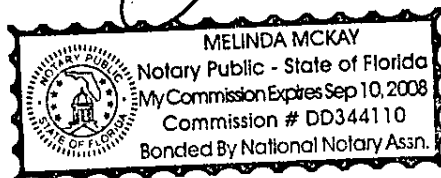
