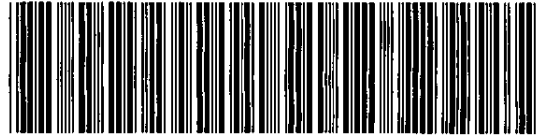

PURSUANT TO FLORIDA STATUTES SECTION 608.411, Paylor Investments, LLC, a Florida limited liability company, whose articles of organization were initially filed on August 8, 2007, hereby adopts the following Amendment to its Articles of organization:

Amendment of Article I as to Name. The Limited Liability Company hereby amends its Articles of Organization to restate Article I thereof as to the designation of its Name, deleting said Article I in the entirety and replacing same with the following:

The name of the Limited Liability Company is:

New Music Ventures, LLC

Date of the Amendment. The Shareholders of the Limited Liability Company adopted this Amendment on October 1, 2007.

Adoption of the Amendment. The Members of the Limited Liability Company adopted this Amendment by unanimous vote and otherwise in a manner sufficient for approval.
