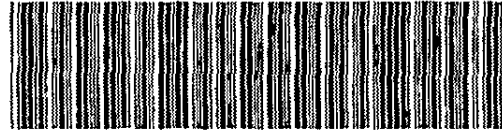


Article IV — Management
