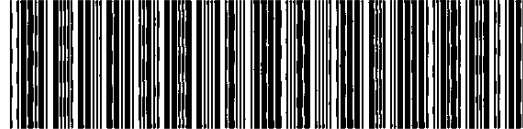


1. The name of the limited liability company is PODS OF NASHVILLE, LLC (the "Company").
