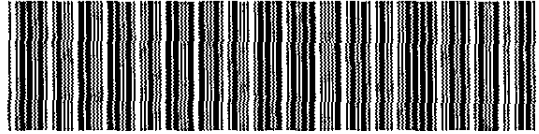




## ARTICLE VII


