#### **ARTICLE 1**

#### NAME

The name of this limited liability company (the "Company") shall be ANDERSON PROPERTIES OF CENTRAL and its mailing address is 425 W. Colonial Dr., Suite 301, Orlando, Florida FLORIDA, 32804, and its principal place of business is 425 W. Colonial Dr., Suite 301, Orlando, Florida 32804.
