Pursuant to the provisions of Chapter 608 of the Florida Statutes, for the purposes of forming a limited liability company under the laws of the State of Florida, the following are the Articles of Organization for Four Horsemen Southeast Florida, LLC.

ARTICLE ONE NATURE OF BUSINESS

This limited liability company may engage in any activity or business permitted under the laws of the United States of America and the laws of the State of Florida.

ARTICLE THREE PLACE OF BUSINESS AND REGISTERED AGENT

The principal place of business of this limited liability company shall be 10475 Cain Circle, Delray Beach, FL 33446 and such other place or places as the members from time to time may determine. The mailing address shall be 10475 Cain Circle, Delray Beach, FL 33446.

ARTICLE FIVE ADMISSION OF ADDITIONAL MEMBERS

This company shall have three (3) members initially. The numbers of members may be increased or decreased from time to time in such manner as may be prescribed by the regulations.

ARTICLE SIX MANAGEMENT OF BUSINESS

Management or conduct of this limited liability company shall be by a member, or members, designated, appointed, elected, removed, or replaced by a vote, approval or consent of the members with voting power prorata to their interest. The rights and duties of the members shall be set forth in the regulations of this limited liability company which are incorporated herein by reference. At the time of executing these Articles of Organization, the members of the limited liability company shall adopt regulations containing all provisions for the regulation and management of this company not inconsistent with law or these articles. Unless otherwise provided for in the operating agreement, in order to be a member of this limited liability company, said a member must also be an employee or partner of Four Horsemen Southeast Florida, LLC.

The power to alter, amend or repeal these regulations shall be vested in the members of this company if decided by majority vote.

ARTICLE EIGHT PROPERTY

Real or personal property originally brought into or transferred to the company, or acquired by the company by purchase or otherwise shall be held and owned, and conveyance shall be made in the name of this limited liability company. The company's regulations shall make a provision as to who may execute instruments and documents relating to property.

ARTICLE NINE MEETING OF MEMBERS

ARTICLE TEN TRANSFERABILITY OF MEMBERS' INTEREST

A member's interest in this limited liability company may be transferred only with the unanimous written consent of all remaining members if the transferee intends to become a member. Without this consent, the transferee shall not be entitled to become a member or to participate in the management of the company, but shall be entitled only to the share of profits, other compensation or return of contributions to which the transferor otherwise would be entitled.

ARTICLE ELEVEN PROFITS AND LOSSES
