**ARTICLES OF ORGANIZATION OF

Article I

The name of the limited liability company ("Company") is EDUCATED GUESS, LLC.

Article II

The mailing and street address of the Company's principal office is 6055 Yellow Pine Trail, DeLeon Springs, FL 32130. The members shall have the power and authority to establish branch offices, or to change the location of the principal office, to such other places as the members may designate.

Article III

The period of duration for the Company is perpetual.

Article IV

The name of the Company's initial registered agent in Florida is LONNIE STOOKSBURY. The address of the Company's registered office in Florida is 6055 Yellow Pine Trail, DeLeon Springs, FL 32130. The mailing address is the same.

Article V

The Company is to be managed by the Members. The Initial Managing Member will serve until the first annual meeting of the Members. The Initial Managing Member is identified as follows:

The remaining members of the Company have the right to continue the business on the death, retirement, resignation, expulsion, bankruptcy, or dissolution of a Member or the occurrence of any other event which terminates the continued membership of a Member in the Company as provided in the Company's Regulations.

Article VIII

The power to adopt, alter, amend, or repeal the Regulations or Operating Agreement of the Company is vested entirely in the Members and any such adoption, alteration, amendment or repeal must be done by unanimous written consent of the Members.
