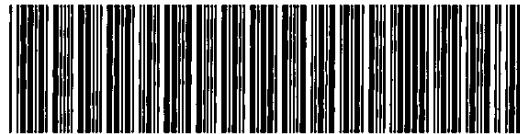

**ARTICLES OF ORGANIZATION  
OF  
SRM GROUP, LLC**

The undersigned members adopt the following Articles of Organization pursuant to the provisions of the Florida Limited Liability Company Act (the "Act").

**ARTICLE I  
NAME OF COMPANY**

The name of the limited liability company is SRM Group, LLC (the "Company").

**ARTICLE II  
PERIOD OF DURATION**

The Company shall terminate on August 8, 2106.

**ARTICLE III

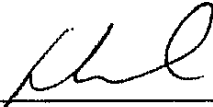

The Company is organized for any legal and lawful purpose for which a limited liability company may be organized pursuant to the Act.

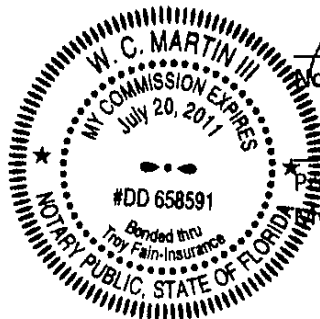
