

The mailing address and street address of the principal office of the Company shall be 5500 Orange Avenue, Fort Pierce, Florida 34947.


**ARTICLE III-REGISTERED OFFICE AND AGENT**

**ARTICLE IV-MANAGEMENT**


The Company shall be a manager-managed company.
