

**ARTICLES OF ORGANIZATION
OF
JAVA DEVELOPMENT LLC**

**ARTICLE I
Name**

The name of the limited liability company is Java Development LLC (hereinafter called the "Company").

**ARTICLE II
Duration**

The existence of the Company shall be perpetual.

**ARTICLE III
Principal Office**

**ARTICLE IV
Initial Registered Office and Registered Agent**

Restrictions on Membership and
Right to Continue After Withdrawal of a Member**
