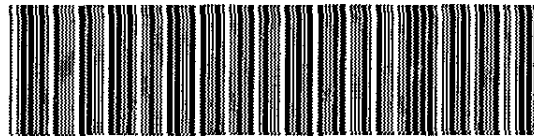


## ARTICLES OF ORGANIZATION
