**ARTICLES OF ORGANIZATION
OF
MOSES INVESTMENTS, LLC**

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Florida Statutes, Chapter 608, hereby makes, acknowledges and files the following Articles of Organization.

ARTICLE I

NAME

The name of the limited liability company shall be Moses Investments, LLC (the "Company"). The mailing and street address of the principal office of the Company in Florida shall be: 411 SE CR 475, Branford, Florida 32008.

ARTICLE II

DURATION

ADDITIONAL CAPITAL CONTRIBUTIONS

Each member shall make additional capital contributions to the Company only upon the unanimous consent of all the members.

ARTICLE VI

ADMISSION AND WITHDRAWAL OF MEMBERS

No additional members shall be admitted to the Company except with the unanimous written consent of the members of the Company.

ARTICLE VII

TERMINATION OF EXISTENCE



MANAGER
