The undersigned, ANCIL L. LINDLEY, III, a natural person competent to contract and a member of MEGLIND. LLC, hereby presents these Articles of Organization as the Articles of Organization of MEGLIND, LLC, a limited liability company formed under the provisions of Chapter 608, Florida Statutes.

#### ARTICLE I - NAME

The name of the limited liability company is:
